## Membership Terms and Conditions

### Privacy

Inner West Referrals Inc. (IWRI) will collect personal information (information) about you, the member which is necessary for or directly related to the functions or activities of IWRI. IWRI's primary purpose in collecting this information is to enable our members to be aware of the services provided by each and every member so that appropriate business referrals that are of benefit to each and every members can be made.

On being accepted as a member of IWRI the member gives express permission to IWRI to distribute such information to each of its members for a lawful purpose, directly related to the functions or activities of IWRI such as :

- (a) to assist in providing goods and services to the member ;

- (c) by operation of law to third parties.

On giving reasonable notice pursuant to the **Privacy Act 1988**, you may access information held by IWRI that is personal to the member and IWRI shall use its reasonable endeavours to reply in a timely manner to the requested access.

### No warranty
